### **MVMA Award Conditions:**

1. MVMA Council to make selection of all award winners.
2. The nominee must be a member in good standing of the MVMA (for Life Member and Veterinarian of the Year).
3. The nominee cannot be currently serving as an elected councilor or staff member of the MVMA.
4. The submission must outline the nominee's qualifications/contributions in support of an award. Nominations without required, supporting documentation will not be considered.
5. Awards are to be presented in conjunction with the MVMA's Annual General Meeting.
6. Council may look to membership or MVMA staff for nominations in a category.
7. Council may make their own nominations at any time.
8. Nominations are not normally carried over to subsequent years. However, Council may ask to set specific nominations aside to be reconsidered the following year, with the consent of the nominator.
9. Council will attempt to give each award every year. The association will make every effort to seek a candidate for each award, each year.
10. These are annual awards and will be presented every year that nominations are received.
