This application form is to be used by a corporation applying for:

- a permit renewal under Rule 3-3 of General By-Law No. 1; or
- a new permit after an earlier permit:
 - was not renewed by the corporation under Rule 3-12,
 - was not renewed by reason of refusal by the MVMA to issue a renewal under Rule 3-16
 - was surrendered by the corporation to the MVMA under Rule 3-12,
 - was revoked by the MVMA under Rule 3-23, or
 - ceased to be valid for any other reason.

A separate application must be used for a permit for each intended veterinary corporation.

1. I am a member of the Manitoba Veterinary Medical Association ("MVMA") holding a valid license to practice veterinary medicine in Manitoba.

2. The Corporation is incorporated, formed by amalgamation, or continued under The Corporations Act of Manitoba, and I enclose with this application a copy of all Articles of Incorporation and amendments thereto, as filed at the Manitoba Companies Office.

3. The Corporation is an existing corporation and is in good standing under The Corporations Act

4. Each voting share of the Corporation is legally and beneficially owned by one or more of the following:

- (a) one or more members of the MVMA, each holding a valid license to practice veterinary medicine in Manitoba; or,
- (b) one or more veterinary corporations.
