1. Call to Order

Dr. Watson called the meeting to order at 7:06 pm. Dr. Watson welcomed the meeting participants including veterinarians and veterinary technologists new to Manitoba and the MVMA. Those members were asked to stand and received a round of applause.

 - Amendment to MVMA By-law Requirement for Insurance (4-1-1) & Auditing of insurance coverage (4-1-2)

Amendemnt to 4-1-1, 4-1-2

Requirement for insurance

4-1-1 Every Practicing Veterinarian Member and Practicing Veterinary Technologist Member shall arrange insurance coverage for himself or herself against professional liability claims in a coverage amount at least equal to the sum per claim that the council may, by resolution, fix from time to time, although any member may, in his or her own discretion, arrange for insurance coverage that exceeds the minimum sum that the council has fixed.

Auditing of insurance coverage

4-1-2 The Registrar may require any Practicing Veterinarian Member **and Practicing Veterinary Technologist Member** to provide proof of current insurance coverage as required by s. 4-1-1 of this by-law, where such proof shall be satisfactory to the Registrar in the form of a binder from the member's insurer.

Proposed Amended By-law

2.14 Library Section

These bylaws are applicable to all practice types. Please note additional requirements at the end of this section.

Library Guiding Principles

The reference library available at the Veterinary Practice (VP) must be relevant to both the type of veterinary medicine being conducted at that VP and the species of animals that are cared for by the VP. It is important for patient care that the veterinarians and veterinary technologists at the VP have prompt access to current, relevant and peer-reviewed medical information. <u>This information can be in the form of printed material, electronic storage format or via the internet</u>. <u>VIN¹ (veterinary information network) deemed to be an acceptable reference source</u>. At the time of inspection, members should be able to demonstrate the ability to access this information. It is the responsibility of the practice that all staff have access to the required reference material that they may require.

Facility and Equipment

The Reference Library must include:

- 1. A current drug formulary (printed or electronic) relevant to the species cared for at the VP and medicines dispensed².
- One current (within the last 1-2 editions) veterinary reference textbook (printed or electronic) on each of the major subject areas practiced at the VP (e.g. these may include but are not restricted to depending on the type of practice - internal medicine, surgery, radiology, emergency medicine, dentistry, anesthesia, clinical pathology, theriogenology, reproductive endocrinology etc.)
- Includes adequate subscriptions to professional journals (at least two referred journals). The Canadian Veterinary Journal (CVJ) and Canadian Journal of Veterinary Research (CJVR) meet the requirements and currently go to all Canadian Veterinary Medical Association (CVMA) members.
- 4. Includes copies (printed or electronic) of the following which must be reviewed annually and updated when revised:
 - a. Current The Veterinary Medical Act of Manitoba
 - b. Current MVMA By-laws
 - c. Current MVMA Code of Ethics

- d. Current MVMA Practice Standards and Practice Standards By-laws
- e. The Animal Care Act (Manitoba), Current
- f. The Animal Disease Act (Manitoba) Current
- g. Current Regulations and Schedule of the *Controlled Drug and Substances Act* (S.C. 1996, c. 19)³ (Canada)
- h. Current Schedule F, G, and H of the *Food and Drug Act* (R.S.C., 1985, c. F-27)⁴ (Canada)
- i. Compendium of Veterinary Products⁵
- j. Material Safety Data Sheets (MSDS)
 - MSDS sheets must be kept indefinitely even if new updates are received and must be reviewed and updated annually. MSDS sheets may be kept online but in an easily accessible file on the computer, preferably on the desktop for immediate access in an emergency. These items must always be available to all staff at any time.
- 5. All required library items shall be in hard copy and/or readily accessible on the computer (in the absence of internet access).

Additional Requirements:

- 1. Embryo Transfer Facility
 - In addition to 1 5 above:
 - Reproductive Biology and Endocrinology
 - Theriogenology
- 2. Large Animal Hospital/Clinic and Large Animal Ambulatory
 - In addition to 1-5 above
 - Compendium of Medicating Ingredients Brochures (If prescribing for feed additives. Only electronic version is current.)
- 3. Specialty Clinic
 - Does not require library as they work out of an inspected facility

- Member Proposed By-law & By-law Amendments
 - Dr. Keri Hudson-Reykdal Amendment & insertion to PIPS By-law 2.7.2.2 Small/Large Animal Mobile Clinics

Current By-law:

2.7.2.2 Small/Large Animal Mobile Clinics

a) Adequate post-operative care is provided. This requires the attending veterinarian to remain in the community for a minimum of 12 hours after completion of the last surgical procedure. Following this period, the attending veterinarian or another veterinarian from their practice must be reasonably available for telephone consultation/follow-up for at least 4 weeks following each visit.

b) There will be a contact person to coordinate appointments and provide contact with the attending veterinarian between visits.

c) Specific location and times of where the mobile clinic will be operating will be provided to the registrar 1 month prior to dates, to ensure that mobile clinic is available for inspections and other MVMA enquiries.

To read:

c) When operating in remote locations, specific location and times of where the mobile clinic will be operating will be provided to the registrar 1 month prior to dates or as soon as reasonably possible, to ensure that mobile clinic is available for inspections and other MVMA enquiries.

d) Specific location and times of where the mobile clinic will be operating do not need to be provided to the registrar if the mobile unit is operating within its regular practice area.

Dr. Liana Mawer and Joan Stewart-Hay had comments on the amendment.
All in favour. Adopted.

• Dr. Chris Bell – Insertion into the MVMA Code of Ethics regarding use of the term specialist and specialty training

12. No member shall represent or imply in any way that they are a 'specialist' or have 'specialty training' if they are not appropriately recognised and credentialed by the American Board of Veterinary Specialties

Commentary:

Page 10 of 11

a) A member approved for registration as a specialist may not use their specialist designation in a manner that implies they are a specialist in an area that they are not recognised in. Discipline or species limitations must be clearly identified.

b) A member shall not use initials or other descriptors following their name unless they are granted or recognised by an approved educational institution or the American Board of Veterinary Specialties.

c) Professional designations granted by registering bodies outside of Manitoba should not be used.

d) Non-practicing members may maintain their professional designation but must not use this designation in a manner that implies that they are entitled to engage in the practice of veterinary medicine. The use of the term "retired" or "non-practicing" after the designation may be used to provide clarity.

e) A registered veterinarian or veterinary technologist who completes a course in dentistry, rehabilitation therapy, chiropractic, acupuncture etc. must not use any designation (e.g. MEqD, CCRT, CCRA, others) or claim certification that would indicate or imply they have obtained a degree granted by a recognized educational institution. A member who completes continuing education or training in dentistry, rehabilitation therapy, chiropractic, acupuncture etc. may communicate that fact to the public in a general sense. e.g. on the veterinary practice website or on a business card.

 Dr. Sarah Bland, Dr. Leanne Bargen, Dr. Trevor Bebchuk, Dr. Janice Posnikoff Ms. Lisa Rea and Dr. Glen Duizer had comments on this amendment.

Dr. Liana Mawer motioned to strike through specialty training. Dr. Glen Duizer seconded. All Opposed. Motioned defeated.

• Ms. Melanie Browning, Dr. Colleen Marion, Dr. Douglas Freeman, WCVM and Dr. Hugh Millar commented on this amendment.

Dr. Hugh Millar motioned to add in part B change approved to "recognized by education institution approved by the MVMA council or the American Board of Veterinary Specialties". Lorna Verschoore seconded.

 Dr. Colleen Marion, Dr. Trevor Bebchuk, Dr. Kenneth Johnson, Mr. Mark Evachewski and Ms. Melanie Browning had comments on this amendment.

Motion Withdrawn.

Dr. Hugh Millar motioned to add in part B a "member shall not use veterinary specialties unless they are granted or recognized by an institution of higher education by the American Board of Veterinary Specialties. Lorna Verschoore seconded. Dr. Trevor Bebchuk and Dr. Colleen Marion had comments on this amendment.

Motion Withdrawn.

Dr. Shauna Richards motioned to refer this proposed by-law to for further clarification. Discussions from the AGM should be considered during the Council's review. Mark Evachewski seconded. all in favour.

10. New Business

Items/issues that MVMA members want to discuss with the AGM assembly

- Ms. Melanie Browning proposed that the MVMA council create a bylaw that requires Animal Health Assistants to submit annual CE to the MVMA. Ms. Browning feels it is not in the public's best interest that they are able to perform the tasks of RVTs but are not required to upgrade their knowledge and skills.
- Ms. Melanie Browning has a concern regarding how by-laws are selected to be voted on electronically vs at the AGM. The council could inadvertently skew the results of a vote. An example would be a vote that affects rural members, many may not be able to attend the AGM, but could easily vote electronically. Ms. Browning ask that the MVMA council create a bylaw or policy to correct this issue.
- Ms. Melanie Browning proposes that the MVMA council creates a code of ethics bylaw that makes retribution by a member against a complainant be professional misconduct.
- Ms. Coral Doherty proposes that council reviews the PIPS requirements and make a statement to members to help them mitigate the risks associated with the storage and dispensing of opioids and narcotics at their practice.

11. Passing of the Gavel

Dr. Richard Hodges passed the gavel to the incoming 2019 MVMA President, Dr. Jonas Watson.

Dr. Watson thanked everyone for the participation and adjourned the meeting at 9:54 pm
