1. Call to Order

Dr. Watson called the meeting to order at 7:08 pm. Dr. Watson welcomed the meeting participants, including veterinarians and veterinary technologists new to Manitoba and the MVMA. Those members were asked to stand and received a round of applause.

2. Adoption of Agenda

Dr. Watson stated that the MVMA by-law requires at least 50 MVMA members need to be in attendance to constitute a quorum for the meeting. Ms. Jo-Anne Holod, MVMA Office Administrator, advised Dr. Watson that 99 members had signed into the meeting.

Dr. Watson stated that the agenda for the AGM had been sent to the members and was also available at the meeting. He asked if there were any objections to the agenda. There were no objections from attendees.

Dr. Watson introduced Ms. Vera Chernecki as the parliamentarian for the meeting.

Dr. Watson advised the guest attendees that Dr. Kent Weir from the SVMA, Dr. Lisa Lomsnes from the ABVMA and Dr. Al Longair from the Society of BC Veterinarians have been appointed as scrutineers for the meeting. He asked if there were any objections to the appointment. There were none.

Dr. Watson advised the attendees that to the manage the meeting the current edition of Robert's Rules of Order Newly Revised would be used. He asked attendees to reference the basics of parliamentary procedure document. He reviewed the rules to follow when speaking during the meeting.

The Adoption of Roberts Rules of Order was moved by Ms. Melanie Browning. The motion was seconded by Ms. Christy Martens. After a vote, the motion was carried.

8. MVMA Council, Committee & Volunteer Reports

Dr. Watson stated that the MVMA Annual Report to Membership, 2019 in Review e-report, was provided to members on the MVMA website before the AGM and printed copies were available at the meeting. Dr. Watson encourages the membership to thank the committee and volunteer representatives who work hard in support of MVMA activities. He urged members to volunteer their time with the MVMA.

Dr. Watson stated that in addition to the MVMA council reports on Council Member Profiles, The MVMA's Volunteer and Committee Day, there will be two discussions tonight on MVMA's Code of Ethics Review and the investigation of an individual engaged in the unauthorized practice of veterinary medicine. Before those items were reviewed, Dr. Watson reviewed new business items brought forward at the 2019 MVMA AGM.

New business presented at 2019 AGM

- 1) Request to create a by-law that requires Animal Health Assistants to submit annual CE to the MVMA.
 - MVMA Council felt that as these individuals are not registered members of the MVMA, that it was not in the best interest of public protection or the profession.
- 2) Request that the MVMA Council develop a policy defining how the MVMA Council determined how a member vote will be conducted.
 - MVMA Council decided that voting either at the AGM or by e-vote, both having pros and cons, will be left up to MVMA Council to decide on the voting type.
- 3) Create a Code of Ethics By-law that makes retribution by a member against a complainant to be professional misconduct.
 - This item is being considered with the Code of Ethics review, which Dr. Pylypjuk will discuss later tonight.
- 4) Request that MVMA Council review the PIPS requirements and make a statement to members to help them mitigate the risk associated with the storage and dispensing of opioids and narcotics at their practice.
 - The MVMA PIPS Committee has suggested that practices balance the narcotics logs minimally monthly and ensure the security of these pharmaceuticals. PIPs rules will be reviewed and potentially amended as the PIPS by-laws are reviewed.

MVMA Code of Ethics Review

Dr. Allison Pylypjuk spoke to the membership that the Code of Ethics is close to the final draft version and will be provided to members for feedback. The proposed model for the revised Code of Ethics is different from the current version as it is not one lengthy document with identified behaviours, rules and examples. Instead, it will move into three parts. First, there will be a document that identifies "Guiding Ethical Principals". The next part will be the hard rules we expect from members – rules that are clear, understandable and enforceable. The final part will be educational documents. The MVMA is looking to employ an online forum for members to share their thoughts, and once all input is received and considered, and revisions are made, the Code of Ethics and any new by-laws will be presented to members for approval. Dr. Pylypjuk thanked all the committee members (12 veterinarians and veterinary technologists and MVMA staff) for their work on this project and a special thank you also to Dr. Terry Whiting for his research and support on this committee.

MVMA's Investigation of an individual engaged in the unauthorized practice of veterinary medicine.

Dr. Watson reported on a matter that was coming to a close. An investigation into Kelvin Asham was engaging in the unauthorized practice of veterinary medicine by acting as a "horse dentist" in Manitoba. Dr. Watson stated that MVMA Council was compelled to settle with Asham's lawyer for a modest monetary sum, a promise not to engage in the unauthorized practice of veterinary medicine and acknowledgment that future breach of law could have unfortunate legal consequences. Dr. Watson also stated that the MVMA has fulfilled its primary duties to protect the public and preserve animal welfare and will continue to keep "Asham" on their radar.

5) Special Orders

A. <u>Treasurer Report</u>

Presentation of Audited Financial Statement ending June 30, 2019

• The MVMA's Council Treasurer, Dr. Richard Hodges, to review the financial statements. Dr. Hodges presented the financial statement to membership. Dr. Watson asked for a motion to approve the financial statements as presented.

 Dr. Jonas Watson advised membership that the MVMA Council had also approved the continued engagement of OnBusiness Solutions as the MVMA Auditors for the ensuing year. Dr. Terry Whiting moved that OnBusiness Solutions continue as MVMA's accountants in 2020. Dr. Scott Zaari seconded. After a vote, the motion was adopted.

Presentation of 2019/2020 budget for information purposes

- The MVMA treasurer, Dr. Richard Hodges, presented the 2019/2020 budget, which had been approved by the MVMA Council. Dr. Hodges asked if there were any questions. There were none.
- Dr. Watson announced that Ms. Trish Lobaton would become the new MVMA treasurer as Dr. Hodges has retired from MVMA Council.
