#### A. Treasurer Report

Presentation of Audited Financial Statement ending June 30, 2021 (Appendix C).

• The MVMA's Council Treasurer, Dr. Jillian Preston-Gren presented the financial statement to membership, and they also were available to view on the MVMA website. Dr. Jillian Preston-Gren asked if there were any questions. There were none. Dr. Pylypjuk asked for a motion to approve the financial statements as presented.

# Dr. Hugh Millar moved to accept the financial statements as presented (Appendix C). Dr. Esther Hill seconded. Discussion: Dr. Marc Philippot had a comment. After a vote, 125 votes in favour and 0 opposed. the motion was passed.

• Dr. Pylypjuk advised membership that the MVMA Council had also approved the continued engagement of OnBusiness Solutions as the MVMA Auditors for the ensuing year.

# Dr. Leeanne Bargen moved that OnBusiness Solutions continue as MVMA's accountants in 2022. Ms. Melanie Browning seconded. After a vote, 122 votes for and 0 opposed, the motion was passed.

#### MVMA Council Proposed By-Law & By-Law Amendments

- i. Amendment to: Veterinary Technologist Application for Registration (2-9-4) of the General By-Law No. 1 of the Manitoba Veterinary Medical Association.
  - Motion to amend Section 2-9-4a of the General By-Law No. 1 of the Manitoba Veterinary Medical Association. The current by-law will be amended to read:

a) be an animal health or veterinary technology or veterinary nursing graduate of a school, college, or institute that the CVMA or the AVMA accredits or provide a PAVE for Veterinary Technicians Certificate

- <u>Voting membership classes</u>: Practicing veterinarian, practicing veterinary technologist, non-practicing veterinarian, and non-practicing veterinary technologist members
- No discussion or comments.

Vote occurred. 113 in favour, 1 opposed and 9 abstained. Motion is adopted.

- New: Holding Animals for Payment Addition to the General By-Law No. 1 of the Manitoba Veterinary Medical Association.
  - Motion to amend Division 6 of the General By-Law No. 1 of the Manitoba Veterinary Medical Association to include the following:

Holding Animals for Payment

A member may not refuse to return an animal, its remains, or its cremains to its owner or owners designate for failure to pay fees owed to a member, practice, or veterinary corporation.

- Voting membership classes: Practicing veterinarian, practicing veterinary technologist, non-practicing veterinarian, and non-practicing veterinary technologist members
- Dr. Jennifer Demare and Dr. Erika Anseeuw had comments on this amendment.

Vote occurred. 93 in favour, 26 opposed and 0 abstained. Motion is adopted.

- iii. New: Publishing Member Data -Addition to the General By-Law No. 1 of the Manitoba Veterinary Medical Association.
  - Motion to amend Division 8 of the General By-Law No. 1 of the Manitoba Veterinary Medical Association. Division 8 will be created to read:

#### Publishing Information

The MVMA shall publish the following information for all veterinarians, veterinary technologists and animal health assistants that hold registration and/or licensure that allows them to practice veterinary medicine under Part 2 of the Act:

- 1. Full name
- 2. Registration class
- 3. Licence status
- 4. Limitations/conditions of the members licence and/or registration
- 5. Full clinic information
- 6. Board certification
- <u>Voting membership classes</u>: Practicing veterinarian, practicing veterinary technologist, non-practicing veterinarian, and non-practicing veterinary technologist members
- Ms. Jenesis Caughy, Dr. Erika Anseeuw, Dr. Claus Leppelmann, Dr. Navjot Dhaliwal, Dr. Cheryl Ilienko, Dr. Jennifer Demare, Dr. Colleen Fisher, Ms. Krystin Sackmann and Ms. Kim Elphick had comments on this amendment.

Vote occurred. 76 in favour, 43 opposed and 0 abstained. Motion is adopted.

- iv. New: Prescribing Opioids, Benzodiazepines and Z-Drugs Addition to theGeneral By-Law No. 1 of the Manitoba Veterinary Medical Association.
  - Motion to amend Division 6 of the General By-Law No. 1 of the Manitoba Veterinary Medical Association. The current by-law will be amended to add:

Prescribing Opioids, Benzodiazepines and Z-Drugs

*Prescriptions for Opioids, Benzodiazepines and Z-Drugs can only be written for a maximum of three months.* 

-and-

Only a one-month supply of Opioids, Benzodiazepines and Z-Drugs can be dispensed at a time.

- <u>Voting membership classes</u>: Practicing veterinarian and non-practicing veterinarian
- Dr. Erika Anseeuw had comments on this amendment.

Vote occurred. 67 in favour, 12 opposed and 0 abstained. Motion is adopted.

- v. Amendment to: Veterinary Technologist Scope of Practice (2-9-10 & 2-9-11) of the General By-Law No. 1 of the Manitoba Veterinary Medical Association (Rabies Vaccine Administration)
  - Motion to amend section 2-9-10 and 2-9-11 of the General By-Law No. 1 of the Manitoba Veterinary Medical Association as follows:

Section 2-9-10 (f) be struck -and-

*The word "excluding" in Section 2-9-11(b) be struck and replaced with the word "including".* 

- <u>Voting membership classes</u>: Practicing veterinarian, practicing veterinary technologist, non-practicing veterinarian, and non-practicing veterinary technologist members
- Dr. Erika Anseeuw, Dr. Kenneth Johnson, Dr. Cheryl Ilienko, Dr. Colleen

   had comments on this amendment.

Vote occurred. 93 in favour, 31 opposed and 0 abstained. Motion is adopted.

- vi. Amendment to: Veterinary Technologist Scope of Practice (2-9-11) of the General By-Law No. 1 of the Manitoba Veterinary Medical Association (Dispensing Prescription Products)
  - Motion to amend Section 2-9-11 and Division 6 of the General By-Law No. 1 of the Manitoba Veterinary Medical Association as follows:
  - The addition of a by-law in Division 6 that:

Prescription products that are dispensed for administration by the animal owner or employee of the animal owner must undergo a final check by a practicing veterinarian member or practicing veterinary technologist member to ensure the dispensed prescription contains:

- 1. The correct prescription product as per the prescription
- 2. The correct dosage as per the prescription
- 3. The correct label that meets the requirements in the Manitoba Veterinary Medical Association Practice Inspection and Practice Standards By-Laws

And the amendment to section 2-9-11 in include subsection "o" that reads " perform a final check of dispensed prescription products as per Division 6 of this bylaw

- <u>Voting membership classes</u>: Practicing veterinarian, practicing veterinary technologist, non-practicing veterinarian, and non-practicing veterinary technologist members
- Ms. Laura Stepien had a comment on this amendment.

Vote occurred. 109 in favour, 9 opposed and 0 abstained. Motion is adopted.

- vii. New: Telemedicine- Addition to the General By-Law No. 1 of the Manitoba Veterinary Medical Association.
  - Motion to amend Section 4-6-2 of the General By-Law No. 1 of the Manitoba Veterinary Medical Association and Section 2.5.13 of the Manitoba Veterinary Association Practice Inspection and Practice Standards By-laws. The current by-laws will be amended as is articulated in pages 22 and 23 of the 2022 MVMA Annual General Meeting Proposed By-Law Amendments booklet (Appendix D).
  - <u>Voting membership classes</u>: Practicing veterinarian, practicing veterinary technologist, non-practicing veterinarian, and non-practicing veterinary technologist members

 Dr. Erika Anseeuw, Dr. Raissa Perrault, Dr. Frederic Beaulac, Dr. Elizabeth Andree, Dr. Chris Bell, Dr. Marc Philippot had comments on this amendment.

- viii. Repeal and Adopt New Code of Ethics Addition to the General By-Law No. 1 of the Manitoba Veterinary Medical Association - Amendment to the Manitoba Veterinary Medical Association Practice Inspection and Practice Standards Bylaws.
  - Motion to amend the General By-Law No. 1 of the Manitoba Veterinary Medical Association and Manitoba Veterinary Medical Association Practice Inspection and Practice Standards By-law and substitute the Code of Ethics as is articulated in Appendix A of the 2022 MVMA Annual General Meeting Proposed By-Law Amendments (Appendix E).
  - <u>Voting membership classes</u>: Practicing veterinarian, practicing veterinary technologist, non-practicing veterinarian, and non-practicing veterinary technologist members
  - No discussion or comments.

Vote occurred. 90 in favour, 16 opposed and 0 abstained. Motion is adopted.

- ix. Amendment to: Method for voting on by-laws (2-5-13) of to the General By-LawNo. 1 of the Manitoba Veterinary Medical Association.
  - Motion to amend Section 2-5-13 of the General By-Law No. 1 of the Manitoba Veterinary Medical Association. The current by-law will be amended at subsection c and d to state:

*c*) voting by ballot delivered electronically; or,*d*) voting by another method conducted in accordance with the by-laws.

- <u>Voting membership classes</u>: Practicing veterinarian, practicing veterinary technologist, non-practicing veterinarian, and non-practicing veterinary technologist members
- No discussion or comments.

Vote occurred. 101 in favour, 3 opposed and 9 abstained. Motion is adopted.

  - Voting membership classes: Practicing veterinarian, practicing veterinary technologist, non-practicing veterinarian, and non-practicing veterinary technologist members
  - No discussion or comments.

Vote occurred. 81 in favour, 4 opposed and 0 abstained. Motion is adopted.

  - Motion that the Manitoba Veterinary Medical Association by-laws be approved as amended.

## 2022 MVMA AGM - BASICS OF PARLIAMENTARY PROCEDURE

**1. Meeting Rules -** Pursuant to MVMA By-laws, the rules contained in the current edition of Robert's Rules of Order Newly revised shall govern MVMA in all cases to which they are applicable and in which case they are not inconsistent with the *Veterinary Medical Act*, MVMA By-laws and any special rules of order that MVMA may adopt.

**2. One speaker at a time -** Only one person may speak at a time. A member may type and submit a comment. The comment will be read by a staff member.

**3. Limited speaking time per member -** On any given motion or topic, each member may speak only twice, for up to the MVMA designated time of three minutes for the first speech and two minutes for the second. This time cannot be combined, split, shared, or yielded to another member. A member who has not yet spoken has priority over another member who wishes to speak for a second time.

**4. Staying on topic -**All member speeches must remain strictly on topic. The current topic will be clarified by the chair if necessary. If there is a motion pending, debate is limited to the merits of that motion. Debate may never go into the motives of particular members or become personal in nature.

**5. All remarks directed to the chair -**All remarks must always be directed to the chair. No member may speak directly to nor address another member or members, except for the chair.

**6. Motions -**A motion is a formal proposal (the "question") to the assembly to make a decision or take an action. A motion is 1) made by a member, 2) seconded by another member, 3) stated by the chair, 4) debated by the members, 5) re-stated (or "put") by the chair, 6) then voted upon by the members. All questions are decided by a majority vote of those members present and voting unless otherwise indicated. A majority is more than half of the members present and voting.

**7. Debate -** The member who introduces a motion is entitled to speak first in debate if he/she so desires. To engage in debate, please type your comment in the bar to the right of the video stream. If you have a longer comment, please send a question mark "?" so we know to wait for your full comment. Your name will automatically be associated with your comment, and will be read with your comment by a staff person.

**8. Amendments -**Any member who believes the pending motion should be modified before it is voted upon may move an amendment to that motion. The motion to amend is processed in the same way as any other motion. While the amendment is being processed, the underlying motion is temporarily set aside. After the vote is taken on the motion to amend, the debate on the underlying motion (as amended or not) resumes.

**9.** Voting - A window will appear on your screen with the item you are voting on. Please cast your vote by clicking on the desired option and then wait for the results.

**10. Points of Order -**A point of order may be raised if the parliamentary procedure rules appear to have been broken. The point is resolved before business continues.

#### 1. PURPOSE OF THE ASSOCIATION

The Manitoba Veterinary Medical Association (MVMA) is the regulatory and professional organization for the veterinary profession in Manitoba. The mission of MVMA is to provide regulatory governance and to empower our members to champion the art and science of veterinary medicine. Legislated by the Province of Manitoba's Veterinary Medical Act, the MVMA is supported by its over 800 veterinarian and veterinary technologist members. Members come to MVMA to obtain and renew their licenses/registrations. The MVMA also regulates the practice of veterinary medicine in Manitoba and ensures that Manitobans have access to qualified veterinary care. Finally, the organization advocates for animal health, grows public awareness of veterinary medicine and keeps members informed and connected to national and international veterinary communities.

The Association is a non-share, not-for-profit organization incorporated provincially under the Corporations Act of Manitoba. As a registered charity the organization is exempt from the payment of income tax under Section 149(1) of the Income Tax Act.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO) and, in management's opinion, with consideration of materiality and within the framework of the following accounting policies:

#### Fund accounting

The Manitoba Veterinary Medical Association follows the deferral method of accounting for contributions whereby restricted contributions related to expenses of future periods are deferred and recognized as revenue in the period in which the related expenses are incurred or in which the related event occurs. Deferred contributions pertaining to the purchase of fixed assets are amortized using the same methods and rates as the fixed assets acquired. The Association maintains three funds as follows:

#### Unrestricted Net Assets

The unrestricted net assets are comprised of the net unrestricted revenues and expenses.

#### Invested in Fixed Assets

The invested in fixed assets are comprised of the net revenues and expenses specifically relating to investments in fixed assets.

#### Internally Restricted - Legal Fund

The internally restricted - legal fund is comprised of the net revenues and expenses to finance legal expenses related to peer review, Practice Inspections, Practice Standards (PIPS), and safeguarding the profession.

#### Contributed services

No amount has been reflected in the statements for contributed services since no objective basis is available to measure the value of such services. Nevertheless, a substantial number of volunteers have contributed significant amounts of their time in the Association's activities.

#### Long term investments

Long-term investments for which there are quoted prices in an active market are carried at fair value. Unrealized gains or losses are reported as part of excess (deficiency) of revenue over expenses.

#### Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

#### Fixed assets

Fixed assets are stated at cost less accumulated amortization. Fixed assets are amortized over their estimated useful lives at the following rates and methods:

Computer equipment	45% to 55%	declining balance method
Furniture and fixtures	20%	declining balance method
Leasehold improvements	10 years	declining balance method
Signage	20%	declining balance method

Fixed assets acquired during the year but not placed into use are not amortized until they are placed into use. Fixed assets are amortized at one-half the normal rate in the year of acquisition.

#### Revenue recognition

The organization follows the deferral method of accounting for contributions.

- services provided to members; association dues, invoiced to members on a calendar year basis, are reported as income for the period to which they pertain,
- there is clear evidence that an arrangement exists
- amounts are fixed or can be determined
- the ability to collect is reasonably assured.

#### Financial instruments

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.

Financial instruments measured at fair value consists of long term investments.

Financial instruments measured at amortized cost consists of accounts receivable, goods and services tax recoverable, loan receivable, accounts payable and accrued liabilities and long term debt.

#### 3. FINANCIAL INSTRUMENTS

The organization is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the organization's risk exposure and concentration as of June 30, 2021.

Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The organization is exposed to this risk mainly in respect of its receipt of funds from its customers and other related sources, long-term debt, and accounts payable.

#### Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency rate risk, interest rate risk and other price risk. The organization is mainly exposed to other price risk.

#### 4. CASH

Cash is comprised of bank balances in both chequing and savings accounts. Both bank balances generate interest at rates of 0.0245% ( 0.0245% in 2020) for balances \$25,000 and over.

Cash includes an internally restricted fund of \$234,116 (\$339,702 in 2020) for purposes of legal expenses that may be incurred by the Association for peer review, PIPS, and safeguarding the profession.

The Association holds substantially all of its cash balance with one financial institution. The cash balance is in excess of the Canadian Deposit Insurance Corporation amount of \$100,000 increasing a cash concentration risk with a risk of loss.

#### 6. LOAN RECEIVABLE

Loan receivable consists of an agreement with the Canadian Animal Blood Bank Inc. (CABB). The loan approved by the Board of Directors of MVMA, is non-interest bearing, unsecured and repayable with annual payments of \$7,000 commencing in 2024 and concluding in 2028.

#### 7. LONG TERM INVESTMENTS

Long term investments consist of an investment savings mutual fund with a cost of \$368,853 (\$367,576 in 2020) and a market value of \$368,853 (\$367,576 in 2020).

#### 9. CVMA MEMBERSHIPS DUES

The MVMA provides collection services to the Canadian Veterinary Medical Association (CVMA). Professional dues collected for and remitted to the CVMA totalled \$133,980 (\$131,428 - 2020). These "custodial" transactions are excluded from presentation on the "Statement of Revenues and Expenditures". The Association receives approximately 4% (2020 - 4%) collection fee for this service from its national association, \$5,455 (\$5,257 - 2020).

#### 10. LEASE COMMITMENTS

The Association is in an office space lease with Midwest Veterinary Purchasing Cooperative Ltd. over a 10-year term which commenced July 1, 2017 and terminates July 31, 2027.

The Association leases a copier/printer on a 5 year term which commenced August 2020 and terminates August 2025. Payments are quarterly at a rate of \$683. In addition, there is a maintenance fee based on number of prints and is fixed over the term of the lease.

#### 11. INTERNALLY RESTRICTED - LEGAL FUND

In 1997, the Province of Manitoba indicated that it wished to transfer responsibilities of the Veterinary Medical Board to the Manitoba Veterinary Medical Association. The Board oversaw the annual registration of veterinarians, the inspection of clinics, conducted investigations into complaints against veterinarians and conducted discipline hearings. The Province of Manitoba introduced legislation that transferred the Board's functions to the MVMA. There was an unrestricted contribution of \$90,000 from the Manitoba Government to the MVMA. These funds and related interest were moved into an internally restricted 'legal fund' in 2010.

An MVMA Council resolution was passed in 2017, that stated the fund will be grown to a maximum of \$350,000 through member dues (transactions are detailed in Schedule 2).

In 2020, the MVMA Council decided to suspend the member legal fee (\$5 for veterinary technologists and \$25 for veterinarians). This decision was in consideration of the potential impact of the Novel Covid-19 pandemic on members and veterinary clinics as well as council's decision to make a larger than usual contribution to the legal fund in June 2020.

#### 12. MARKETING ALLOCATION

An MVMA Council budgeting item was discussed in 2018 to implement a marketing fund to be collected via a \$25 per member annual fee. No separate bank account will be set up and the amounts are part of unrestricted general revenues and expenses.

## **Appendix D**

## Proposed section 4.6.2 of the General By-law No. 1 of the Manitoba Veterinary Medical Association:

#### Telemedicine

4-6-2.1 A Practicing Veterinarian Member may establish a VCPR without a hands-on examination of an animal and/or visiting the premises where the animal is kept only if the member documents a compelling justification and rationale for why establishing VCPR solely via telemedicine is needed. Further:

- A. The member cannot prescribe any Control Substances, Benzodiazepines or class-Z drugs when the VCPR that is established solely through Telemedicine.
- B. The veterinarian providing Telemedicine in Manitoba must be licensed in Manitoba.
- C. A VCPR cannot be established for a group of animals (for example a herd, flock, or school) of animals via telemedicine.
  - 1) A VCPR can be established via telemedicine alone if the animals are intended for personal use only and there is not reasonable access to veterinary care.
- D. The veterinarian must be practicing out of an MVMA PIPS Inspected Practice that holds a valid Telemedicine Permit.
- E. When practicing via telemedicine, the veterinarian must:
  - 1) Disclose their identity, location and licence status;
  - 2) Confirm the identity of the client and animal(s);
  - Consider the existing health status of the animal or group of animals, the specific health needs and specific circumstances, and only use telemedicine if the risks do not outweigh the potential benefits;
  - 4) Identify what resources (e.g. information and communication technology, equipment, support staff, etc.) are required, and only proceed if those resources are available and can be used effectively;
  - 5) Ensure the reliability, quality and timeliness of the information obtained;
  - Protect the privacy and confidentiality of the client's and animal(s) information, inclusive of evaluating the technology and the physical setting;
  - 7) Ensure the physical setting in which the care is being delivered is appropriate and safe, including having a plan to manage adverse events and/or emergencies;
  - 8) Explain to the client any limitations of proceeding with telemedicine to provide the veterinary services required; and,
  - 9) Provide access to in-person follow-up care in Manitoba.



## Proposed section 2.5.13 of the Practice Inspection and Practice Standards By-Law of the Manitoba Veterinary Medical Association:

#### 2.5.13 Telemedicine Permit

a. A veterinary practice that holds an Inspection Certificate under section 2.1.1 may apply to the Registrar for a Telemedicine Permit.

b. Each veterinary practice that holds a Telemedicine Permit must provide a copy of all telemedicine records to an MVMA Inspector upon request for audit. The veterinary practice must pay a Telemedicine Audit fee for each audit.

**4-6-13** Prior to treating an animal, the Practicing Veterinarian Member must first communicate to the client the potential risks and benefits of treatment and obtain the clients informed consent to treatment.

a) In the event of urgent and unexpected treatment, a Practicing Veterinarian Member may provide veterinary services without informed consent. The Practicing Veterinarian Member must inform the client of services provided and obtain informed consent on an ongoing basis once the Practicing Veterinarian Member is practicably able to do so.

MANITOBA VETERINARY MEDICAL ASSOCIATION CODE OF ETHICS

**Preamble** - Members of the MVMA engage in principle-based ethical practice of veterinary medicine. These principles promote the ethical provision of veterinary service. Members of the MVMA uphold the following core ethical principles:

#### INTEGRITY

Members demonstrate integrity when they:

- Are accountable to their clients, patients, and the public at large.
- Are honest in their communications.
- Identify and avoid conflicts of interest.
- Maintain the trust of clients and society.

#### COMPASSION

Members demonstrate compassion when they:

- Approach their clients and patients with compassion.
- Treat themselves with compassion and practice self-care.
- Treat fellow members and colleagues with compassion.

#### RESPECT

Members demonstrate respect when they:

- Extend respect to clients, patients, colleagues, other health professionals and the public.
- Display respect for clients through open communication and informed consent.

#### IMPARTIALITY

Members demonstrate impartiality when they:
Uphold human dignity. No member shall discriminate on grounds of race, gender, economic status, religion, politics, disability, marital status, or sexual orientation.

#### Animal Welfare & Animal Health

Members uphold animal welfare and animal health when they:

- Promote animal health.
- Acknowledge that the welfare of animals is a central role for practice.
- Report animal abuse and reportable diseases.
- Recognize a responsibility to improve animal welfare and health.

#### COMPETENCE

Members demonstrate competence when they:

- Ensure competence in the practice of veterinary medicine.
- Practice only within their range of competence.
- Engage in ongoing continuing education.
- Demonstrate competence to clients and the public through sharing their knowledge and expertise of animal health, animal welfare and human health.
- Help to promote the competence of the profession by engaging in mentorship.

#### CONFIDENTIALITY

Members demonstrate confidentiality when they: • Uphold the principle of confidentiality and keep information obtained in their professional dealings confidential. Exceptions exist when appropriate disclosure concerns public health, animal health and/or welfare.

The Code of Ethics will be in force an effect as per by-laws 4-3-1 and 4-3-2 of the MVMA General By-Law No. 1

## **Appendix F**

#### Division 3 – Vacancies and removal of council members

#### 2-3-1 Removal of council member

Where any elected council member, any council member appointed to fill an elected council member's vacancy, or the immediate past president

(a) fails without excuse acceptable to the council in its sole discretion to attend three (3) successive regular meetings of the council; (b) fails without excuse acceptable to the council in its sole discretion to attend at least 80% of regular meetings of the council that are convened within a single fiscal year;

(c) is found guilty of professional misconduct or conduct unbecoming a member, pursuant to s. 40 of the Act, or any other finding set out in s. 40 of the Act;

(d) is issued a formal caution pursuant to s. 23(1)(c)of the Act;

(e) voluntarily surrenders the member's certificate of registration or licence pursuant to s. 23(1)(e) of the Act;

(f) is convicted of an offence punishable by more than six (6) months imprisonment or is sentenced to a term of imprisonment, whether conditional or otherwise;

(g) has his or her registration or licence suspended pursuant to s. 21.1 or 29(1) of the Act; or,

(h) is found by a court to be of unsound mind,

he or she then ceases to be a council member.

## Obligation of council member entering into an agreement under s. 23(1)(d) of the Act

**2-3-2** Where any elected council member, any council member appointed to fill an elected council member's vacancy, or the immediate past president enters into an agreement with the Complaints Committee pursuant to s. 23(1)(d) of the Act, that member must, within 30 days after having entered into such an agreement, either resign his or her membership in the council, or must inform the President that he or she has entered into such an agreement. Where the council member also is the President, the council member must inform the Vice-President that he or she has entered into an agreement pursuant to s. 23(1)(d) of the Act. ## Council to vote on removal of council member who has entered into an agreement under s. 23(1)(d) of the Act

**2-3-3** Where, in accordance with s. 2-3-2 of this by-law, a member or the Registrar informs the President or Vice-President, as the case may be, that the member has entered into an agreement pursuant to s. 23(1)(d) of the Act, the council shall, as reasonably soon as possible, vote on whether or not to remove the member from membership in the council. Where a majority of the council voting on the resolution approves the removal of the member from membership in the council member.

#### Breach of the Council Code of Conduct

**2-3-4** Any council member may make a motion to find a Council Member in breach of the Council Code of Conduct.

**2-3-5** If a council member is found to be in breach of the Council Code of Conduct by a majority vote of the council members voting on the matter, a council may resolve by motion to take any of the following actions:

- a) Reprimand the council member;
- b) Require the council member to issue a public apology;
- *c) Remove the council member (the member then ceases to be a council member).*

#### Report to the minister about public representative

**2-3-46** Where a majority of the President, the Vice-President, and the immediate past president determine in their sole discretion that the conduct of a public representative council member unfavourably reflects upon the association or any of its officers, council members, staff, or members, the President may report the conduct to the minister.

#### Filling of vacancies

**2-3-5** Other than a vacancy in a public representative position, the council must fill the vacancy on the council pursuant to s. 6(10) of the Act.
