7. 2022 Reports: Annual, Committee, Council

Dr. Hudson Reykdal stated that the MVMA Annual Report to Membership, 2022 in Review e-report, was provided to members on the MVMA website before the AGM. Dr. Hudson Reykdal encourages the membership to thank the committee and volunteer representatives who work hard in support of MVMA activities. She urged members to volunteer their time with the MVMA.

8. 2022 AGM Minutes

The MVMA Council has reviewed and approved the 2022 MVMA AGM minutes and are available to members on the MVMA website.

9. Finances

a. Presentation of Treasure Report

The MVMA's Council Treasurer, Dr. Jillian Preston-Gren presented the treasurer report to membership.

- The responsibilities of the treasurer include:
 - Providing financial oversight through a monthly books review
 - Monthly financial reporting to the MVMA Council
 - Serving as the primary contact for financial related issues
 - Key Council member involved in budget development.
 - Work toward developing a future financial plan for the MVMA
- The MVMA currently uses Scotiabank for day-to-day banking and Scotia McLeod for investments.
 - We have explored financial planning options with them but were unable to find solutions that meet our needs.
- It is my recommendation as outgoing treasurer that the MVMA engage with a professional financial planner who can give our association impartial advice.

c. Auditor for Fiscal Year Ending June 30, 2023: Motion to Appoint

Dr. Hudson Reykdal advised membership that the MVMA Council had also approved the continued engagement of OnBusiness Solutions as the MVMA Auditors for the ensuing year.

Vote #1 – Small Animal Emergency Hospital

- Dr. Mackenzie Marks made a motion on behalf of the MVMA Council to adopt the five additions to the Practice Inspection Practice Standards Bylaw as is articulated in Appendix A of the 2023 MVMA By-Law Booklet. (Appendix E)
- **Voting membership classes**: Practicing veterinarian and non-practicing veterinarian members
- No debate or discussion

Vote occurred. 42 in favour, 1 opposed and 2 abstained. Motion is adopted.

Vote #2 – Internship

- Dr. Mackenzie Marks made a motion on behalf of the MVMA Council to adopt the amendments to Part 2, Division 8 of the MVMA General By-law No1 Internships as set out on pages 7-10 of the Booklet (Appendix E)
- **Voting membership classes**: Practicing veterinarian and non-practicing veterinarian members
- No debate or discussion

Vote occurred. 41 in favour, 3 opposed and 2 abstained. Motion is adopted.

Vote #3 – Board Certification and Residency

- Dr. Mackenzie Marks made a motion on behalf of the MVMA Council to adopt the amendments to Part 2, Division 8 of the MVMA General By-law No1 Board Certification and Residency as set out on pages 13 and 14 of the Booklet. (Appendix E)
- <u>Voting membership classes</u>: Practicing veterinarian and non-practicing veterinarian members
- No debate or discussion

Vote occurred. 44 in favour, 2 opposed and 3 abstained. Motion is adopted.

Vote #4 – Apiculture VCPR

- Dr. Mackenzie Marks made a motion on behalf of the MVMA Council to adopt the addition to Part 4 division 6 of MVMA the General By-Law No Apiculture VCPR as is set out on page 16 of the Booklet. (Appendix E)
- **Voting membership classes**: Practicing veterinarian and non-practicing veterinarian members
- No debate or discussion

Vote occurred. 35 in favour, 3 opposed and 3 abstained. Motion is adopted.

Vote #5 – Fees/Membership all members

- Dr. Mackenzie Marks made a motion on behalf of the MVMA Council to adopt the amendments to the MVMA General By-law No1 as is set out in Appendix B of the Booklet. (Appendix E).
- Voting membership classes: Practicing veterinarian, non-practicing veterinarian, practicing veterinary technologist and non-practicing veterinary technologist members
- No debate or discussion

Vote occurred. 83 in favour, 2 opposed and 5 abstained. Motion is adopted.

Vote occurred. 42 in favour, 0 opposed and 3 abstained. Motion is adopted.

- Dr. Mackenzie Marks made a motion on behalf of the MVMA Council to adopt the by-law changes to the MVMA General By-Law No 1 as is set out in Appendix D of the 2023 MVMA By-Law Booklet (Appendix E)

- Melanie Browning RVT, Cindy Sontag RVT and Dr. Colleen Fisher had comments on this amendment.

Vote occurred. 14 in favour, 32 opposed and 1 abstention. Motion is lost.

Appendix A



2023 MVMA Virtual Annual General Meeting Rules

Introduction

In ranking order, the rules to ensure effectiveness and fairness of the MVMA AGM are found in:

- 1. Law: Rules prescribed by applicable legislation: *The Corporations Act* and *The Veterinary Medical Act*
- 2. Bylaws: Organizational rules relating to the MVMA itself: General By-law No.1
- 3. Written Rules of Order
 - (i) Parliamentary Authority: RONR
 - (ii) Special Rules: See Below
 - (iii) Standing Rules: See "Basics of Parliamentary Procedure"
 - (iv) Custom: Long-standing practices treated as written rules

The MVMA's Special and Standing Rules are to be read together.

Adoption of Special Rules requires a 2/3rds vote by Membership.

Adoption of the Standing Rules requires a majority vote by Membership.

Once adopted, Special Rules supersede any conflicting rules set out in RONR or in the Standing Rules.

Special Rules

General

- 1. The 2023 AGM is being conducted virtually via the GetQuorum platform; it will be recorded for minute-taking purposes.
- 2. Preparing for participation in the virtual format is the responsibility of Members.

 To facilitate the smooth transaction of business and in consideration of all Members, technical support on an individual basis during the AGM will not be provided.

Agenda

Each Agenda topic will be briefly introduced by the Chair.
 Members may ask questions on any matter identified in the Agenda.
 The Chair, or a Council Member, will provide answers.
 The Chair may also;



- a. permit staff persons and consultants with expertise in the matter to answer; and
- b. exercise discretion to determine the matter will be addressed outside of and following the AGM.

Comment/Debate Time Limits

- 4. When making comment on any Agenda topic, or in debate on any Motion, Members' time is limited to:
- a. Firstly: no longer than three [3] minutes to read.
- b. Secondly: no longer two [2] minutes to read.
- 5. Debate on all original motions shall be limited to ten [10] minutes.
- 6. The Chair may extend, or seek Members' permission to extend, the time limits set out above in Rules 4(a) or 4(b).

The Chair may also receive a Motion to extend debate, provided that such a Motion is made before the ten [10] minutes stipulated above in Rule 5 has expired. Extending debate requires a 2/3rds vote by Membership.

Voting

7. The Chair will announce which class of Membership Class is entitled to vote on the Motions.

Regardless of Membership Class entitlement, no Member shall vote upon any Motion in which there is a conflict of interest and any such vote will be disallowed.

8. If Members are attending the AGM in a group setting, only one [1] vote is permitted per registration.

In a group setting, every Member must be registered and logged-in to participate in the meeting as an individual.

Votes are cast independently, not as a group total.

Minutes

9. All Members will have access to exchanges of information arising at the AGM, through a summary document, to be attached to the Minutes of the 2023 AGM.



Appendix B

2023 MVMA AGM - Basics of Parliamentary Procedure

- **1. Meeting Rules -** Pursuant to MVMA By-laws, the rules contained in the current edition of Robert's Rules of Order Newly revised shall govern MVMA in all cases to which they are applicable and in which case they are not inconsistent with the *Veterinary Medical Act*, MVMA By-laws and any special rules of order that MVMA may adopt.
- **2. One speaker at a time -** Only one person may speak at a time. A member may type and submit a comment in the bar to the right of the video stream. The comment will be read by a staff member.
- **3. Limited speaking time per member -** On any given motion or topic, each member may speak only twice, for up to the MVMA designated time of five minutes for the first speech and three minutes for the second. This time cannot be combined, split, shared, or yielded to another member. A member who has not yet spoken has priority over another member who wishes to speak for a second time.
- **4. Staying on topic** -All member speeches must remain strictly on topic. The current topic will be clarified by the chair if necessary. If there is a motion pending, debate is limited to the merits of that motion. Debate may never go into the motives of particular members or become personal in nature.
- **5. All remarks directed to the chair -**All remarks must always be directed to the chair. No member may speak directly to nor address another member or members, except for the chair.
- **6. Motions -**A motion is a formal proposal (the "question") to the assembly to make a decision or take an action. A motion is 1) made by a member, 2) seconded by another member, 3) stated by the chair, 4) debated by the members, 5) re-stated (or "put") by the chair, 6) then voted upon by the members. All questions are decided by a majority vote of those members present and voting unless otherwise indicated. A majority is more than half of the members present and voting.
- **7. Debate -** The member who introduces a motion is entitled to speak first in debate if he/she so desires. To engage in debate, please type your comment in the bar to the right of the video stream. If you have a longer comment please send a question mark "?" so we know to wait for your full comment. Your name will automatically be associated with your comment, and will be read with your comment by a staff person.
- **8. Amendments -**Any member who believes the pending motion should be modified before it is voted upon may move an amendment to that motion. The motion to amend is processed in the same way as any other motion. While the amendment is being processed, the underlying motion is temporarily set aside. After the vote is taken on the motion to amend, the debate on the underlying motion (as amended or not) resumes.
- **9. Voting -** A window will appear on your screen with the item you are voting on. Please cast your vote by clicking on the desired option and then wait for the results.
- **10. Points of Order -**A point of order may be raised if the parliamentary procedure rules appear to have been broken. The point is resolved before business continues.

To the Members of The Manitoba Veterinary Medical Association

We have reviewed the accompanying financial statements of The Manitoba Veterinary Medical Association that comprise the statement of financial position as at June 30, 2022 and the statements of revenues and expenditures, changes in net assets and cash flow for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements based on our review. We conducted our review in accordance with Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements.

A review of financial statements in accordance with Canadian generally accepted standards for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with Canadian generally accepted auditing standards. Accordingly, we do not express an audit opinion on these financial statements.

PURPOSE OF THE ASSOCIATION

The Manitoba Veterinary Medical Association (MVMA) is the regulatory and professional organization for the veterinary profession in Manitoba. The mission of MVMA is to provide regulatory governance and to empower our members to champion the art and science of veterinary medicine. Legislated by the Province of Manitoba's Veterinary Medical Act, the MVMA is supported by its over 800 veterinarian and veterinary technologist members. Members come to MVMA to obtain and renew their licenses/registrations. The MVMA also regulates the practice of veterinary medicine in Manitoba and ensures that Manitobans have access to qualified veterinary care. Finally, the organization advocates for animal health, grows public awareness of veterinary medicine and keeps members informed and connected to national and international veterinary communities.

The Association is a non-share, not-for-profit organization incorporated provincially under the Corporations Act of Manitoba. As a registered charity the organization is exempt from the payment of income tax under Section 149(1) of the Income Tax Act.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO) and, in management's opinion, with consideration of materiality and within the framework of the following accounting policies:

Fund accounting

The Manitoba Veterinary Medical Association follows the deferral method of accounting for contributions whereby restricted contributions related to expenses of future periods are deferred and recognized as revenue in the period in which the related expenses are incurred or in which the related event occurs. Deferred contributions pertaining to the purchase of fixed assets are amortized using the same methods and rates as the fixed assets acquired. The Association maintains three funds as follows:

Unrestricted Net Assets

The unrestricted net assets are comprised of the net unrestricted revenues and expenses.

Invested in Fixed Assets

The invested in fixed assets are comprised of the net revenues and expenses specifically relating to investments in fixed assets.

Internally Restricted - Legal Fund

The internally restricted - legal fund is comprised of the net revenues and expenses to finance legal expenses related to peer review, Practice Inspections, Practice Standards (PIPS), and safeguarding the profession.

Contributed services

No amount has been reflected in the statements for contributed services since no objective basis is available to measure the value of such services. Nevertheless, a substantial number of volunteers have contributed significant amounts of their time in the Association's activities.

Long term investments

Long-term investments for which there are quoted prices in an active market are carried at fair value. Unrealized gains or losses are reported as part of excess (deficiency) of revenue over expenses.

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

Fixed assets

Fixed assets are stated at cost less accumulated amortization. Fixed assets are amortized over their estimated useful lives at the following rates and methods:

Computer equipment	45% to 55%	declining balance method
Furniture and fixtures	20%	declining balance method
Leasehold improvements	10 years	declining balance method
Signage	20%	declining balance method

Fixed assets acquired during the year but not placed into use are not amortized until they are placed into use. Fixed assets are amortized at one-half the normal rate in the year of acquisition.

Revenue recognition

The organization follows the deferral method of accounting for contributions.

- services provided to members; association dues, invoiced to members on a calendar year basis, are reported as income for the period to which they pertain,
- there is clear evidence that an arrangement exists
- amounts are fixed or can be determined
- the ability to collect is reasonably assured.

Financial instruments

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.

Financial instruments measured at fair value consists of long term investments.

Financial instruments measured at amortized cost consists of accounts receivable, goods and services tax recoverable, loan receivable, accounts payable and accrued liabilities and long term debt.

3. FINANCIAL INSTRUMENTS

The organization is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the organization's risk exposure and concentration as of June 30, 2022.

Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The organization is exposed to this risk mainly in respect of its receipt of funds from its customers and other related sources, long-term debt, and accounts payable.

Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency rate risk, interest rate risk and other price risk. The organization is mainly exposed to other price risk.

4. CASH

Cash is comprised of bank balances in both chequing and savings accounts. The savings account generates interest at a rate of 1.31% (2.45% in 2021) for balances \$25,000 and over.

Cash includes an internally restricted fund of \$186,152 (\$234,116 in 2021) for purposes of legal expenses that may be incurred by the Association for peer review, PIPS, and safeguarding the profession.

The Association holds substantially all of its cash balance with one financial institution. The cash balance is in excess of the Canadian Deposit Insurance Corporation amount of \$100,000 increasing a cash concentration risk with a risk of loss.

7. LOAN RECEIVABLE

Loan receivable consists of an agreement with the Canadian Animal Blood Bank Inc. (CABB). The loan approved by the Board of Directors of MVMA, is non-interest bearing, unsecured and repayable with annual payments of \$7,000 commencing in 2024 and concluding in 2028.

8. LONG TERM INVESTMENTS

Long term investments consist of an investment savings mutual fund with a cost of \$370,317 (\$368,853 in 2021) and a market value of \$370,317 (\$368,853 in 2021).

11. FUNDS HELD IN TRUST

The MVMA administers the registration process for veterinary technologists so that they are able to obtain registration with the MVMA and the Manitoba Veterinary Technologists Association (MVTA) through a sole registration process. The MVMA collects fees on behalf of each member for MVTA and holds it in trust. The MVMA will remit fees held in trust on at least a quarterly basis with information containing the name of each person that money was collected from, and the amount of money collected on behalf of the MVTA.

12. CVMA MEMBERSHIPS DUES

The MVMA provides collection services to the Canadian Veterinary Medical Association (CVMA). Professional dues collected for and remitted to the CVMA totalled \$137,388 (\$133,980 - 2021). These "custodial" transactions are excluded from presentation on the "Statement of Revenues and Expenditures". The Association receives approximately 4% (2021 - 4%) collection fee for this service from its national association, \$5,617 (\$5,455 - 2021).

13. LEASE COMMITMENTS

The Association is in an office space lease with Western Drug Distribution Centre (WDDC), previously under Midwest Veterinary Purchasing Cooperative Ltd. who was purchased by WDDC, over a 10-year term which commenced July 1, 2017 and terminates July 31, 2027.

The Association leases a copier/printer on a 5 year term which commenced August 2020 and terminates August 2025. Payments are quarterly at a rate of \$683. In addition, there is a maintenance fee based on number of prints and is fixed over the term of the lease.

14. INTERNALLY RESTRICTED - LEGAL FUND

In 1997, the Province of Manitoba indicated that it wished to transfer responsibilities of the Veterinary Medical Board to the Manitoba Veterinary Medical Association. The Board oversaw the annual registration of veterinarians, the inspection of clinics, conducted investigations into complaints against veterinarians and conducted discipline hearings. The Province of Manitoba introduced legislation that transferred the Board's functions to the MVMA. There was an unrestricted contribution of \$90,000 from the Manitoba Government to the MVMA. These funds and related interest were moved into an internally restricted 'legal fund' in 2010.

An MVMA Council resolution was passed in 2017, that stated the fund will be grown to a maximum of \$350,000 through member dues (transactions are detailed in Schedule 2).

15. MARKETING ALLOCATION

An MVMA Council budgeting item was discussed in 2018 to implement a marketing fund to be collected via a \$25 per member annual fee. No separate bank account will be set up and the amounts are part of unrestricted general revenues and expenses.

The proposed by-law amendments will be voted on at the 2023 MVMA AGM. As per section 7(2) of *The Veterinary Medical Act* and section 2-5-6 of the MVMA General By-law No. 1, the MVMA Council identified which membership classes will vote on the proposed amendments. Voting membership classes are identified in each proposed by-law amendment section.

Summary of Proposed By-Law Amendments

Below is a list of the proposed by-law amendments being presented at the 2023 MVMA AGM. For more information about each proposed amendment, including the current by-law, the proposed by-law, as well as the rationale behind the proposed amendment, please review the information in the Proposed By-law Amendments section.

As you will note, the MVMA Council has grouped together some of the by-law amendments, so that they are voted on as a package of amendments, rather than individual amendments. The Ad Hoc PIPS Rewrite Committee began its work in 2021. While it anticipates that its work will be complete by the 2024 AGM, it believes that changes to Small Animal Emergency Hospitals should be addressed on a more timely basis.

The risks identified by the Ad Hoc PIPS Rewrite Committee include the risk of anesthesia being provided without an RVT to monitor and the risk of emergency practices not having needed equipment to provide service.

Risks/issues the MVMA Council seeks to address

The Ad Hoc PIPS Rewrite Committee identified the following risks and offers the following proposals to address these risks:

- 1) Risk 1- Lack of requirement to have an ultrasound machine Under the current rules, a Small Animal Emergency Hospital is not required to have an ultrasound machine. The MVMA Council seeks to add an ultrasound machine as a requirement for Small Animal Emergency Hospitals.
 - 2) Risk 2- Staffing Requirements



There are currently no staffing rules for Small Animal Emergency Hospitals. Inappropriately staffed Small Animal Emergency Hospitals pose a patient safety risk and a risk to the reputation of veterinary professionals. The MVMA Council seeks to ensure that at least one veterinarian and one veterinary technologist are on the premises during business hours. To ensure that the rule is enforceable, the MVMA Council seeks to require business hours reporting requirements for Small Animal Emergency Hospitals.

- 3) Risk 3- Lack of requirement to have radiology equipment Under the current rules, a Small Animal Emergency Hospital is not required to have radiology equipment. The MVMA Council seeks to add radiology equipment as a requirement for Small Animal Emergency Hospitals.
- 4) Risk 4- Lack of requirement to have clinical pathology equipment Under the current rules, a Small Animal Emergency Hospital is not required to have clinical pathology equipment. The MVMA Council seeks to add clinical pathology equipment as a requirement for Small Animal Emergency Hospitals. This would also include equipment that would allow for the determination of coagulation times.

2) Amendment to Part 2, Division 8 of the MVMA General By-Law No 1-Internships

MVMA Council Proposed By-Law Amendment

<u>Voting membership classes:</u> Practicing Veterinarian Members and Non-Practicing Veterinarian Members

Background

Currently, graduates of veterinarian programs not accredited by the CVMA or AVMA cannot provide any veterinary services in Manitoba unless they:

1)Enroll in the National Examining Board program and pass the BCSE (written exam), NAVLE (written exam) and sign up for the Pre-Surgical Assessment exam; or,

2)Complete the PAVE for Veterinarians program (1 year in an accredited program and pass the NAVLE and BSCE)

Those looking to complete an internship in Manitoba cannot do so unless they complete the pathway above.

Definitions

Internship- Internships are opportunities for non-board-certified veterinarians to get experience and less formal training from a board-certified veterinarian. Internships can allow general practitioners to better understand specialist practice before undertaking a formal residency program (required for board certification). It is also an opportunity for those foreign to Canada to better understand the Canadian practice of veterinary medicine.

Manitoba is currently facing a shortage of veterinary professionals. Veterinary graduates of programs not accredited by the CVMA or AVMA currently have limited pathways to obtain licensure in Manitoba. The MVMA is currently taking steps to address this issue.

Veterinary graduates of programs not accredited by the CVMA or AVMA that are seeking internship opportunities and supervised by board-certified veterinarians are believed to pose a low risk in practice on a short-term basis.

Background

Currently, graduates of veterinarian programs not accredited by the CVMA or AVMA cannot provide any veterinary services in Manitoba unless they:

1)Enroll in the NEB and pass the BCSE (written exam), NAVLE (written exam) and sign up for the Pre-Surgical Assessment exam, or,

2)Complete the PAVE for Veterinarians program (1 year in an accredited program and pass the NAVLE and BSCE)

Under the current rules, board-certified specialists, diplomates and those engaged in residency programs would be required to complete the above examinations to be eligible to provide service in Manitoba.

Definitions

Residency- an approved residency that is recognized by the AVMA American Board of Veterinary Specialties (ABVS), or equivalent.

Manitoba is currently facing a shortage of veterinary professionals. Veterinary graduates of programs not accredited by the CVMA or AVMA currently have limited pathways to obtain licensure in Manitoba. The MVMA is currently taking steps to address this issue.

Veterinary graduates of programs not accredited by the CVMA or AVMA that are board-certified, have diplomate status or are in a residency program are believed to pose a low risk in practice within their area of specialty.

Pathway 1- Board Certification

In this pathway, a veterinarian that is a graduate of a program not accredited by the CVMA or AVMA that is board certified by, or a diplomate of, a veterinary specialty organization that is recognized by the AVMA American Board of Veterinary Specialties (ABVS), or equivalent, is eligible to obtain a limited licence in Manitoba. Their scope of practice would be limited to their board certification.

Pathway 2- Residency Program

In this pathway, a veterinarian that is a graduate of a program not accredited by the CVMA or AVMA that is enrolled in a residency program of a veterinary specialty organization that is recognized by the AVMA American Board of Veterinary Specialties (ABVS), or equivalent, is eligible to obtain a limited licence in Manitoba. Their scope of practice would be limited to their board certification, and they would need to practice under the supervision of a Practicing Veterinarian Member.

Voting

These two pathways will be voted on together as they are interrelated. To allow solely residents to practice in Manitoba would not be supported if there is not a reasonable pathway to unrestricted licensure in Manitoba. Conversely, Manitoba's ability to attract foreign educated veterinarians in board-certification programs will be significantly hampered without the ability to have residents practice in Manitoba.

Background

Health Canada directed that the use of Medically Important Antimicrobials (MIA) in food producing animals shall be under veterinary oversight by the end of 2018. At that time, the CVMA undertook research in a number of areas including <u>Providing Veterinary Oversight of Antimicrobial Treatment of Agricultural Bee Populations</u>.

At that time, most Canadian jurisdictions adopted a framework similar to the one articulated in Providing Veterinary Oversight of Antimicrobial Treatment of Agricultural Bee Populations.

The MVMA created the <u>Apiculture VCPR Guidance Document</u> based on the CVMA report in the event that this By-Law is passed.

Risks/issues the MVMA Council seeks to address

The MVMA Council identified the following risks/issues and offers the following proposals to address these risks/issues:

1) <u>Definition of Membership</u>

The MVMA Council wishes to ensure that the definitions of members and membership classes reflect the membership types that the MVMA currently offers and ensure that membership types properly reflect voting rights under *The Veterinary Medical Act* and the MVMA General By-Law No.1.

2) Annual Meeting Notification Rules

The MVMA Council seeks to clarify who should be given notice of the annual meeting: only those holding a current registration and or licence are entitled to notice of the annual meeting.



3) Calculation of fees for less than a full year

The MVMA Council seeks to ensure that the MVMA is able to attract short-term locums to the province as we continue to face a significant shortage of veterinary professionals. The current rule requiring members to pay at least 25% of the total annual membership fee is viewed as overly punitive, and a financial barrier to practices looking to hire locums from outside of the province.

There are also concerns that the current 25% minimum fee for membership can disproportionately affect members that are primary caregivers, face medical issues that may limit the members' ability to practice, etc.

The MVMA Council submits that the monthly prorated fee should be maintained; however, the minimum 25% membership fee provision of the current bylaw should be removed.

4) <u>Discretionary Fee Refunds</u>

The current by-law allows the Executive Director to exercise discretion when refunding fees to members that voluntarily cancel their membership or move to a less expensive membership type.

The MVMA Council does not believe that this type of decision should be left to the Executive Director as it is not transparent, nor does it promote fairness amongst the membership.

Instead of leaving fee refunds to the discretion of any one person or group, the MVMA Council seeks to be more transparent in terms of fee refunds.

The MVMA Council seeks to automatically refund membership fees on a monthly prorated basis.

Given that this will increase the number of refunds that are issued and will use MVMA's staff time, the MVMA Council submits that this refund should automatically be given; however, the MVMA will charge an administrative fee when providing the refund. This administrative fee is to ensure that the MVMA is recouping the cost of administering refunds and not promoting members from frequently switching categories to save small amounts of money.

Risks/issues the MVMA Council seeks to address

The MVMA Council identified the following risks/issues and offers the following proposals to address these risks/issues:

1) Issue 1- Separating veterinarian registration from licensure

The MVMA has reviewed veterinarians' registration and licensure requirements. The MVMA Council would like to clarify the obligations of those solely registered versus those holding an active licence to practice veterinary medicine.

The MVMA wishes to streamline the registration process and ensure that the MVMA and the National Examining Board, which issues Certificates of Qualification, are not duplicating work. As diploma verification is also undertaken by the National Examining Board, the MVMA Council does not wish to require the additional burden on applicants to provide original or notarized copies of diplomas. It is believed that removing this requirement will streamline the registration process.



The MVMA seeks to remove some requirements for registration that are more appropriately needed for licensure solely. For this reason, the MVMA Council seeks to remove the requirement for declarations about professional liability insurance and continuing education to more effectively capture them under licensure requirements.

The MVMA believes that membership with the CVMA and supporting the CVMA is essential. The MVMA Council believes that membership with the CVMA should be required for all veterinarians licenced to practice in Manitoba. However, for retired and otherwise non-practicing veterinarians, the MVMA believes that compulsory membership with the CVMA may pose a financial hardship. Therefore, the MVMA looks to remove the CVMA membership requirement from registration and instead move it to licensure requirements.

2) <u>Issue 2- Licensure requirements</u>

The MVMA Council wishes to ensure that veterinarians registered with the MVMA meet additional requirements to ensure their suitability to practice veterinary medicine at the time of licensure, including:

- that they hold current membership with the CVMA.
- that they are covered by adequate professional liability insurance and that members moving into this practicing category have time to obtain professional liability insurance.

While the MVMA believes that supporting the CVMA is imperative for the veterinarian profession in Canada, the MVMA Council submits that those who practice in Manitoba for less than 90 days a year should not be required to hold CVMA membership. The MVMA Council believes that this will drastically lower the fees for those looking to hire short-term locums and for non-profit agencies looking to have veterinarians from outside of the province provide service on a short-term basis.

The MVMA clarifies that the requirement to write the Seminar and Exam and attend the AGM are already included in section 2-8-7 of the MVMA General By-Law No 1.

3) Issue 3- Short term veterinarian fees

The MVMA Council is looking to streamline fees and ensure that Manitoba is able to attract short-term members for locums and other short-term work in the province (including short-term non-for-profit veterinary services). In order to ensure that MVMA members are able to attract locums, the MVMA is looking to allow for shorter-term licences that are not as cost prohibitive.

The MVMA Council seeks to remove the short-term licensure category, which is currently very costly for veterinarians coming to the province for short-term locums.



The MVMA Council also wishes to move these types of fee matters into the fees section of the General By-Law No.1.

Risks/issues the MVMA Council seeks to address

The MVMA Council identified the following risks/issues and offers the following proposals to address these risks/issues:

The MVMA aims to streamline the registration process and ensure parody for veterinarian and veterinary technologist members.

The MVMA believes that the Manitoba Veterinary Technologists Association provides invaluable support to veterinary technologist members and supports the organization.

The MVMA Council believes that membership with the Manitoba Veterinary Technologists Association should be required for veterinary technologists that hold a registration that permits them to practice veterinary medicine in the province; however, veterinary technologists that are in a non-practicing category, such as those that are on medical leave, family leave, or retired, etc., should not be required to hold membership with the organization.



The MVMA Council instead proposes to move the requirement to be a member of the Manitoba Veterinary Technologists Association to a section specifically speaking to practicing veterinary technologist members.

The MVMA Council is looking to clarify the requirements for veterinary technologists that hold a registration that entitles them to practice veterinary medicine in the province.

While additional requirements may be added in the future, currently the sole requirement would be holding registration with the Manitoba Veterinary Technologists Association.
