LIMITED LICENSURE – COMPETENCY ASSESSMENT TOOL DEVELOPMENT

Subject Matter Expert (SME) Group – Terms of Reference

MANDATE:

The Subject Matter Expert (SME) Group is responsible for providing the content expertise necessary to develop competency assessment tools for limited licensure candidates based on a portfolio and supervision components. The goal of this project is to assess the competence of veterinarians within a proposed limited scope of practice, administered by the National Examining Board.

RESPONSIBILITIES:

Working under the direction of the CAMPROF Canada, the responsibilities of the SME Group are to:

- Identify and review relevant information that could inform the content of the assessment tools: literature, veterinary competency profile, data provided by regulatory bodies, personal experiences, curriculum, etc.
- 2) Work collaboratively (online meetings and offline homework) to draft, review and revise assessment criteria and the proposed supervision framework;
- 3) Provide input on assessment indicators, eligible evidence weightings, standardized evaluation criteria, measurement and scoring system;
- 4) Act as beta testers during the pilot phase to validate the assessment tool, as necessary.

COMPOSITION:

The SME Group is composed of seven to eight members that include the following:

- regulatory representatives;
- practicing veterinarians;
- veterinary medicine educators;
- representation from various:
 - o locations (i.e., from a variety of regulated jurisdictions);
 - years of experience (i.e., new and experienced practitioners); and
 - practice settings (i.e., large animal, small animal, equine).

SME Group members must also meet the following criteria:

- demonstrated ability to work effectively in small groups;
- a commitment to problem-solving and achieving consensus for the purposes of developing a pan-Canadian program;
- good written and verbal communication skills;
- a strong understanding of the skills, knowledge and attributes associated with entry-level veterinary medicine in Canada; and
- availability to attend meetings according to the following schedule.
